SUN REPORTER, OCT. 5, 1978, MARK LANE PRESS CONFERENCE

"Jonestown is a model community". Lane's visits there gave him a glimpse of the future".

"1200 Americans fled in search of human rights not available to them in the ghettos of America."

"The government of Guyana is particularly pleased by the success of the People's Temple, since it is a model for other Caribbean countries to follow".

"Formerly impoverished people are living together without crime, drugs, or hopelessness".

(or food, or sex, or free time, or mail from home, or privacy or sleep)

"The education of young people in Jonestown is much more sophisticated and successful than in U.S. schools".

"There is no money in Jonestown and no need for it".

(only \$3,000,000 cash in one trunk)

"The community's 1200 members are served by 70 health workers. It can be compared to Albert Schweitzer's famous hospital in Africa."

(Who visited? Mengeles from Brazil?)

S.F. EXAMINER, Oct. 4, 1978

"The concentration camp charges against Jonestown were false."

"Lane hinted he would be filing a multi-million-dollar suit against the government, the FBI, CIA, State Dept, Internal Revenue, Treasury Department, Postal Service". Government agencies "were embarrassed because of Jonestown success", Lane.

(All these agencies named were funding or protecting Jim Jones and the operation at Jonestown.)

NEWS RELEASE FROM PEOPLES TEMPLE, Oct. 21, 1978

"Charles Garry, attorney for Rev. Jones and Peoples Temple, enthusiastically refers to the community where racism, sexism, ageism have been overcome as an answer to a better life."

Don Freed, author, said, "Martin Luther King, if he could see Jonestown, would recognize it as the next step in his agenda, and say, "One, two, three, many more Jonestowns."

Was this project moved to Jonestown? Jim Jones had lived in Brazil, with CIA, U.S. Embassy, before receiving mental patients in Ukiah, Calif. He arrived in Ukiah with \$100,000.

DEAR STUB: I am in possession of confidential information to the effect that the Army is prepared to turn over Nike missile bases to state and local agencies for non-military purposes. They may look with special favor on health-related applications.

Such a Nike missile base is located in the Santa Monica Mountains, within a half-hour's drive of the Neuropsychiatric Institute. It is accessible but relatively remote. The site is securely fenced, and includes various buildings and improvements making it suitable for prompt occupancy.

If this site were made available to the Neuropsychiatric Institute as a research facility, perhaps initially as an adjunct to the new Center for Prevention of Violence, we could put it to very good use. Comparative studies could be carried out there, in an isolated but convenient location, of experimental or model programs for the alteration of undesirable behavior.

Such programs might include control of drug or alcohol abuse, modification of chronic antisocial or impulsive aggressiveness, etc. The site could also accommodate conferences or retreats for instruction of selected groups of mental health-related professionals and of others (e.g., law enforcement personnel, parole officers, special educators) for whom both demonstration and participation would be effective modes of instruction.

My understanding is that a direct request by the Governor, or another appropriate officer of the State, to the Secretary of Defense (or, of course, the President) would be most likely to produce prompt results. Needless to say, I stand available to participate in any way that might be helpful.
