"Will not run for President in 1980."

"Would accept Vice-President".

Haig the protégé of Henry Kissinger and David Rockefeller.  
 Put into White House after tape removed Pres. R. Nixon.

Eveland wrote to me, "I've been impressed hearing you on KGO", "I  
 admire what you are doing." Other newscasters totally ignorant of  
 Middle East.

"TORRIJO'S QUICK ASSENT ON SHAH SURPRISED JORDAN, NYT, 12/17/79

"Jordan calls General Torrijos "Papa".

"The general frequently speaks of Mr. Jordan as "my son."

"As Shah departed, lawyers prepared an affidavit designed to free  
 the Shah from having to submit testimony on Saturday (next day).

"Every other country except Egypt declined to accept the Shah."

"REBEL STUDENTS FLAUNT SECRET EMBASSY FILES AS 'PROOF' OF SPY NEST."

N.Y. Post, 12/21/79

"In Teheran, guidelines were not followed, no reason why not destroyed".

1. Failed to destroy contents of ambassador's personal safe.

2. Maintained unnecessary file copies of highly sensitive cables.

3. Reference to intelligence and sensitive diplomatic contacts by  
 real names.

4. Maintained so-called "soft files", notes, drafts of cables, and  
 memoranda not in official records, therefore not destroyed.

5. Careless handling of sensitive cover information for intelligence  
 operatives under diplomatic cover in Tehran.

CIA, State Dept. fighting over security lapses.

## "HOUSE UNIT CHIDED IN CASE OF ASSASSIN RAY'S KIN"; WP, 12/25/79

G.Robert Blakey, May 24, 1979, "Primary reason to charge John Ray with perjury" before the House Assassinations Committee" was to force James Earl Ray, alleged assassin of Rev. Martin Luther King, to reveal more about the King assassination".

Justice Dept. claims Blakey, Committee, acted "improperly".

## "REPUTED MOBSTER'S DONATION TO CONNALLY", UPI, 12/13/79

Mo Dalitz, Morris Barney Dalitz, 12/29/79, \$1,000 to John Connally. Torbit Document, Assassination Cabal.

Mo Dalitz, John Connally both linked to JFK, RFK, MLK deaths.

Mo Dalitz, Vegas, close associate of Robert Maheu, of Howard Hughes, Summa Corp., CIA, FBI, and assassination teams from organized crime.

## "SOVIETS, VIETS HOLDING UP CAMBODIAN AID, CONGRESS TOLD" UPI, 12/19/79

Expert Leo Cherne, chairman of Citizens Commission on Indochinese Refugees, now advisor to House Foreign Affairs subcommittee, 1979.

Cherne with CIA agents who formed Symbionese Liberation Army, 1974. Cherne, International Rescue Committee, CIA, Lee, Marina Oswald, 1962.

Cherne, with Pres. G. Ford, Nelson Rockefeller, CIA Intelligence Committee.

## "U.S. Counseled to MAKE PERMANENT ITS HUMAN RIGHTS", NYT, 12/11/79

William T. Coleman, heads 22 member panel, 1979, Human Rights.

Coleman, former Secy. of Transportation, Gerald Ford, 1974.

Coleman with Gerald Ford, Warren Commission, 1964, covering up JFK assassination with Nazi, Navy Intelligence links. Coleman, atty. for Nelson Rockefeller, Phil. connections.

## "BROWN TO ATTORNEY GENERAL: PROBE EGGER. Herald Examiner, 12/14/79

Tapes #292, 10/23/77, and other Hughes tapes.

Jack Eggar, Beverly Hills Police Officer, supplied narcotics to Howard Hughes, Beverly Hills Hotel bungalow, 1957 to 1966. while Hughes a prisoner. Notified before and after Bobby Hall, drug connection, was murdered by the killers and never warned or reported the contacts.

Mike Reagan, Ronald's son, told Mike Curb, Lt. Gov. with Ken Reitz, "appoint".

Watergate dirty trick bag-man with Haldeman, to have Brown "appoint".

"Narcotic Addict Evaluation Authority", \$18,711 Part time job", Eggar.

"California Crime Resistance Task force". for Eggar.

The appointment was rescinded by Brown. (close call)

## "EX-FBI INFORMANT PLEADS FOR U.S. AID", L.A. Times, 12/14/79

State Bar Board of Governors, Calif., asked for \$200,000, for ex-con.

"Compensation for former FBI informant" to set up a business.

"Worked with Tribal Thumb, activist group, supplied weapons to kill Black activist Popeye Jackson, Sally Voyer, 6/8/75. Jackson gunned down.

Mae: I was in Popeye's home two weeks before the murder and tried to warn him about the people surrounding him.  
Sara J. Moore, Federal Agent, help set up Popeye's death.  
Later attempted assassination of Pres. Ford.
