SUMMIT MEETING OF MOB BOSSES POSTPONED BECAUSE OF ABSCAM, AP, 2/13/80

Organized crime bosses planning summit meeting.
Similar in importance to Apalachin, N.Y. 1957, more than 60 met.

Howard Hughes, Mob, CIA, Vatican, Watergate.
The first link from Bruce Roberts.

"Purpose to carve new geographical boundaries for mob, narcotics, extortion, traffic". Blackmail, murders, politicians involved.

TRYING TO STOP THE INVESTIGATIONS? Atty. General B. Civiletti.

SoHo, New York, "FBI, federal crime force said Civiletti tried to shut the operation". (That would protect Carter, mob, Vatican.)

Civiletti is Carter's John Mitchell. Let G.W. Miller off hook, Richard Blumenthal, 33, U.S. Attorney, brought in to "investigate the leak" of Abscam, worked for Richard Nixon, White House.

These premature "leaks" of Abscam, Brilab, Pensordf, slowing down nationwide connections of Organized Crime to White House, Justice.

"STATE REPORT SEES CASINOS BRINGING 'OMINOUS CLOUDS' TO ATLANTIC CITY".

Martin Waldron, NYT 1/20/80 (week before Abscam story broke)

"Elderly, poor being moved out of Atlantic City"

"Rapid increase of jobs affecting skyrocketing land values", etc.
(A lot of people lose, others gain, when mob moves in.)

"FBI'S LATEST TIES THE MOB TO POLITICIANS", S.F. Examiner, 2/9/80.

"\$10,000 payment to Lt. Gov. Fitzmorris, La."

"\$10,000 payment to William Clayton, Texas, speaker of the House."

"Carlos Marcello" linked to FBI investigation, "long considered Louisiana's mob chief and who the HOUSE ASSASSINATIONS COMMITTEE said may have had some role in the killing of President John F. Kennedy" Named as part of FBI "Brilab", Southwest.

CARLOS MARCELLO, New York Times, 2/11/80, links to FBI "Abscam"

Mario T. Noto, deputy commissioner of Immigration, soon to retire.
Noto offered "lush job" by Marcello, BOSS OF MOB, after govt. work.

Noto worked on the staff of the SENATE LABOR COMMITTEE, of which Sen. Harrison Williams, is Chairman. Williams just taped, photographed with huge pay-offs linked to New Jersey casinos.

Sen. Williams' wife also part of his professional staff, direct links to Casino Commission, Abscam exposures.

Marcello wanted possible deportation restrictions lifted, working with Immigration. Fight with Sen. R. Kennedy about 1953 restrictions.

ABSCAM, BRILAB, PENDORF. Fifty more to come. What next?

ABSCAM Code name Arab-scam, FBI disguised as Arabs.

FBI, Justice Dept. entrapment of selected, guilty, public officials. Described as "most serious since Watergate", is Watergate II. Located in N.Y., N.J., Miami, South Carolina, Washington, D.C. Will spread. One Senator, Six members of U.S. House of Representatives, and 20 or more public officials and government workers, attorneys, mob.

BRILAB Code name for Bribery-Labor. Targeting labor, not management.

FBI, using informers, Prudential Insurance Co., L.A. as cover. Involves Los Angeles, Louisiana, Texas, Oklahoma, Arkansas. Same mobsters, Senators, Representatives will link to ABSCAM. Carlos Marcello, La., example of Brilab and Abscam.

PENDORF Code name for Dorfman, Allen, Organized crime, Political Corruption. TEAMSTERS, mob.

Broader investigation, began two years ago. Dorfman convicted in 1972, Teamsters "loan", \$50,000 kickback. Sen. Howard Cannon; Las Vegas, Illinois, Southwest, Calif., Nevada. Carlos Marcello, La., assassination teams, links to Pendorf.

"JUDGE, TOLD BY FBI OF PLOT TO BRIBE HIM, QUILTS TRIAL", L.A. Times, 2/7/80
5 accused of racketeering, extortion, murdering of Frank Bompensiero. Aladena (Jimmy the Weasel) Fratianno chief witness. U.S. District Judge Harry Pregerson WARNED BY FBI, CARLOS MARCELLO gang coming in with \$100,000 art object for easy prosecution.
Question: WHY DIDNT FBI WAIT AND SEE IF PREGERSON TOOK THE BRIBE?
If FBI set up this network to catch criminals, public officials, why do they warn some, let others be caught?
That is the heart of this scandal, selective exposure.
FBI, Justice politically controlled by Organized Crime.

"MURPHY ONCE CALLED 'THE WORST CONGRESSMAN'", 2/7/80, Wash. Post.

Sept. 24, 1979, Village Voice, Jack Newfield, on Rep. John M. Murphy, D.N.Y.

Newfield reported nearly 10 situations of Murphy's "incredible pattern of trying to enrich himself at the expense of the public interest".

Murphy links to Thomas Gambino, son of late Mafia leader C. Gambino. Murphy links to Iranian oil, Gen. Anastasio Somoza, Nicaragua. Murphy links to Shah of Iran, FBI investigation of kickback for construction of Pahlavi Foundation in Manhattan. Murphy on Pahlevi board of directors.

WILLIAM TAUB, Tapes #425, # 426, "Missing oil paintings, Gainsborough

and Ruben's "Bowl of Fruit", moved by TEAMSTERS (Pendorf, linked to Brilab and Abscam) Vatican gift to Taub, stolen. Did these set off investigations 13 years later? I cant find out yet. Why not? What "stolen art", taken "13 years ago", started this inquiry?

Howard Blum (Search For Nazis in America) writing for N.Y. Times, cant get name of paintings. Impossible to identify.
