Herbert Hoover and United Fruit banana plantation.

John J. McCloy, former high commissioner of West Germany, who unleashed former Nazis, past president of World Bank that kept money from Guatemala, attorney for Chase Manhattan Bank and member of Warren Commission to investigate JFK murder, Board member of United Fruit.

John Foster Dulles, Secy. of State, legal aide to United Fruit.

Allen Dulles, CIA Director, president of United Fruit Board, member of Warren Commission to conceal assassins of JFK, used CIA to overthrow Jacob Arbenz in the mid 50's.

Henry Cabot Lodge, Nixon Vice-President, Amb. to Vietnam when Diem murdered, Board of Directors, United Fruit. Lost to JFK, 1960.

E. Howard Hunt, Nixon, Watergate coup operations chief, CIA man involved in overthrow of Arbenz.

General Walter Bedell Smith, Eisenhower's commanding officer, WWII, Director of CIA, Board of United Fruit.

The relationship of profits, government policy, intelligence agencies, the military all webbed together. "National Security" means maximum profits at our expense.

BELLI AND A FAMOUS BOAT, S.F. Examiner, 4/25/80

Melvin Belli representing Emmy Goering, widow of Nazi Hermann Goerring. Payment: anything over \$500,000.

"Fine condition, berthed at Hamburg."

Suggested as boat of President Ronald Reagan.

Belli attorney for Jack Ruby after wiping out patsy Lee Harvey Oswald. Concealed Nazi links to JFK. assassination. Attorney for best friend Errol Flynn's family, to hide Nazi connections, Gestapo-USA.

Newly released memo, Graham urging President Dwight D. Eisenhower to campaign for Nixon in 1960 against "Catholic Kennedy".

1960 the year assassination teams set up by CIA, FBI, to get Kennedy family if they moved politically.
