Politicking now. "This is a party duty I have".

Hayakawa named as recipient of South African, racist, money.

FAULTY TRAINING CITED IN SAN DIEGO CRASH (third reference to this)
3/29/79 Worst air disaster in USA, 144 killed.

Curb vs. Lt. Gov. Dymally. Dymally supposed to be on that flight.
Crash Sept. 25, 1978, months before elections.

Still controversy, discrepancies on cause. Wont wash away!!!

Shades of Dorothy Hunt, Dec. 1972, Watergate fatality in Chicago,
and Obershain crash, Va. John Warner then won Senate seat.

Watch these pre-election crashes and the discrepancies in the
hearings and investigations. That is the clue, one of them.!!

Also, people with common interests, goals, associations linked.

PENTHOUSE INTERVIEW, Stephan Jones, April, 1979

December, 1973, went to Guyana with mother, father, more than 12
Temple Members. (Same month as arrest, prior to cover-up.)

"Mom and dad there in early 60's, on trip back from Brazil."

"Jones got lease 30 miles from Matthews Ridge, near Venezuela."

"In 1973 we went out to Matthews Ridge" (MATTHEWS RIDGE CIA STATION.)

JUST BEFORE OR AFTER LA. ARREST ON HOMOSEXUAL CHARGES, JONES WITH 12
OTHERS PREPARING MOVE TO GUYANA. Dec. 1973. 2/22/70, Burnham Prime Minister.
Burnham put in by CIA. Cheddi Jagan ousted.

L.A. City Attorney Burt Pines ordered Municipal Judge Clarence
Stromwell to "seal and destroy" arrest record of Jim Jones. 1/31/74

Judge Stromwell ordered LAPD, FBI, CII and "other agencies" to
"destroy, seal." BURT PINES "DESTROY JONES, 1974", "DESTROY 1976 FILES"

L.A. City Attorney destroyed "4 tons" police complaints by citizens
in 1976. Controversy will continue. (Tape #381, 3/23/79) PINES THEIR
CLEAN UP MAN. Newspapers don't refer to him by name, protect him.

Tim Stoen, Stanford attorney, Assistant D.A., Menocino County, Calif,
stepped in with Calif. Courts and law-enforcement.

THE WEIGHT OF THE TIM STOEN CONTACTS FOR INSIGNIFICANT PERVERT JONES

Dale Speck, then Assistant L.A. Police Chief, with CIA in 1974.
Now DIRECTOR OF LAW ENFORCEMENT DIVISION, STATE ATTORNEY
GENERAL'S OFFICE.

MIKE FRANCHETTI. Now Chief assistant to State Attorney General's office.

ATTORNEY GENERAL EVIL YOUNGER. His network in Calif. created the
Manson, SLA, Jonestown, Kemper, Frazier, Zebra, Zodiac network of violence.

COVER STORY FOR LETTING JONES OFF. Dr. Alex Finkle, S.F. 12/14/73

"Jones had to jump and joggle to urinate".

Letter arrived one day after arrest. It took all that Calif. weight,
plus \$5,000, plus Ed. Davis's assistant letter. "Masturbating and
other activities in the theater lobby" charged by arresting officers.

"Jones actions more sexual than therapeutic". Officer A. Kagele.
