"Cut \$67 million, summer schools, adult education, community colleges".

"Cut \$500 million welfare, it is an outrage".

"Abolish aides for local schools, special programs, State Energy Comm."

"YOUNGER WOULD LEGALIZE POT" L.A. Times 9/13/78

S.F. Chronicle, 9/17/78, "Marijuana is America's Number 3 business, \$48 billion industry". Earlier, Younger hard on pot users, but when establishment gets into the business, it seems O.K.

"CALIFORNIA'S OWN POLITICAL POLICE" Inquiry Magazine, by Bill Wallace.

Feb 6, 1978. Expose of Younger's Red Squad, not for Organized Crime.

"OCCIB may be the beginning of a new, centralized political surveillance."
Formed 1970. Not a single arrest of major underworld figure".
