VAN NUYS SUSPECT, EXTRADICTED FROM ARGENTINA, FACES MURDER PLOT CHARGE LAT 5/22/80

Jack Eggars tape #292, 10/23/77

Antonio Regulsky, 39, brought from Argentina on plot to kill Eggars.
Eggars, Beverly Hills Police Dept., notified before and after
Robert Hall killed 7/22/76. Hall, Eggars, kept HOWARD HUGHES doped,
prisoner from 1957 to 1966, when delivered by MOB and CIA to Boston
Hospital, never seen again. Defense Dept. could buy up VEGAS in
Hughes name, control mobsters, skimming money, crime, prostitution, etc.

MIKE CURB recommended JACK EGGARS to CALIFORNIA CRIME RESISTENCE
TASK FORCE, to "encourage citizen involvement in crime prevention".

If Eggars wanted to prevent crime, he could have called Robert
Hall or called off his murder. Prevent crime with another crime?
He could have released Howard Hughes, prisoner in Beverly Hills.
