"Seventeen years I waited, I didn't make any trouble for 17 years".

"I thought the conspiracy people were loony. Then I said, open the grave and see for yourself."

I am 99% sure "the body is not there", Marina Oswald.

James Earl Ray, alleged assassin of Rev. M.L. King, refused hearing.

INFORMATION FOR INTERNATIONAL ORGANIZATIONS, AMNESTY INTERNATIONAL, BERLIN. 11/24/80

Investigate Pope John Paul II, Auschwitz concentration camp, work for Solvay-I.G.Farben, Nazi agent, Pope Paul VI, Nazi exits abroad.

Colonia Dignidad, Nazi experimentation, mind control, links to Jonestown, CIA. World Watchers will go to Berlin.

DONALD E MacDONALD, AKA RICHARD R. HUGHES. Interview 11/26/80

Claims that original Howard Hughes wills, located 3 places, destroyed. At least 8 people murdered to conceal original will, witnesses. Drugged with Alloxin, starts diabetes, coma, shock, almost fatal.

Soon to be Dell paperback.

THE MISSING SWISS SAFE DEPOSIT KEY, Flynn Nazi agent of Gestapo.

P.341 Oct.1, 1959

Vancouver, B.C. "heart attack", taken to Dr. Grant Gould.

The Dr., others, leave him alone in room, Flynn dies.

From time of death to autopsy, Safe Deposit key, Swiss bank account, always around his neck, removed. Safe Deposit emptied. Half million, papers, bonds, etc

BEVERLY AADLAND, FLYNN FEMALE COMPANION, TAKEN AS "WARD" OF ATTY. Melvin Belli.

P.343 Aadland met at L.A. airport, taken away in Mrs. Melvin Belli's car.

"Beverly Aadland became the temporary ward of the Bellis."

Mrs. Aadland, Beverly's mother, allowed Belli to take over.

Belli attorney for Errol Flynn, Jack Ruby, Hell's Angels, Charles Wynan, Mrs. Herman Goering and other fascists, close links to Howard Hughes Organization.

1940, Warner Bros. Errol Flynn, Ronald Reagan, Santa Fe TRail. Same studio, same movie.

1942, Warner Bros. Errol Flynn, Ronald Reagan, Desparate Journey. Same studio, same movie.

1940-1942, Flynn with top Gestapo, German Nazis, Mexico City, LA, Bahamas, links to Canadian Sir Harry Oakes, (murdered 1943), Duke-Duchess of Windsor, Axel Wenner Gren, Barcelona Nazi contacts of Dr. Erben. What rubbed off on Reagan?
