BACKGROUND OF DAVID LIFTON

B.A.Cornell School of Engineering Physics, 1962.

Job as computer engineer at Space and Information Systems Div., of North American Aviation, prime contractor for Apollo project. Working at North American by night, UCLA, advanced degree, by aday.

ALLEGATIONS

1. The corpse of President Kennedy/surgically altered.

2. "Medical forgery" before official autopsy began, to conceal.
3. Bullet wounds and scalp injuries on JFK rearranged by doctors.

4. Purpose of pre-autopsy surgery "disguise and deception".

5. There was a break in the chain of possession of JFK body.

6. Secret Service agents were responsible for the corpse.
7. Military guards lost the President's coffin. Wrong coffin.

8. Pentagon top officials, Army and Navy personnel, were covering.

9.Motive for surgical altering was to misdirect inquiries.

10. Doctors were protecting the real assassin, on grassy knoll. 11. Wounds in JFK had to be consistent with location of L.H. Oswald.

12. Warren Commission members, staff, simply diverted by JFK wounds.

13. Commander James Humes, Col. Pierre Finck, and Dr. J. Thorton Boswell, Chief of Pathology at Bethesda, deceived.

14. Chief Justice Earl Warren didnt "lie" about JFK, didnt know.

15.Military commands of silence from officers, enlisted men.

16.0swald, patsy, was behind JFK car, so wounds had to be consistent with location of selected scapegoat.

WHAT IS WRONG WITH LIFTON THESIS?

- 1. Location of altering JFK body never identified.

 CON Air Force One en route to D.C?, Walter Reed, Bethesda hospital? Cant define, locate where it could take place.
- 2. <u>Identification</u> of doctors with authority to alter JFK body missing. All suspected medical staff cleared, "it is my belief none of the three autopsy surgeons were in a plot to alter the body". Who could do it?
- 3. Secret Service only Govt.agency named, excluding FBI, DIA, CIA participation in accompanying the body.Navy Hospital. DISC.NSA.
- 4. No necessity to surgically arrange JFK body. History written with fountain pens, razor blades, ink, not with flesh.
- 5. Plot would include Oswald murder, so need for this trouble.? JFK dead, alleged assassin to be killed 48 hours later, no necessity to be part of a criminal cover-up. No trials.
- 6. Warren Commission, John J.McCloy (Chairman of Chase Manhattan), Allen Dulles, CIA Director, Rep. Gerold Ford, CIA Leon Jaworski, Richard Russell, CIA liason to Congress, others, not "lost" or confused by a FBI report or later changes in the report.

WHAT IS WRONG WITH LIFTON'S 700 PAGE BOOK?

- 7.Lifton's emotional and psychological necessity to prove something to CIA attorney Wesley Liebeler, UCLA. Too much effort on dead rock.
- 8.Lifton's emotional and psychological necessity to prove the attornies, staff, as well as the Commission, intended to find truth but were confused by a pre-autopsy surgery. <u>BULL SHIT</u>. They were CIA, DISC, DIA criminals, lying, concealing. Lifton knew this once. What price, how many dollars and hours, to rearrange his mind?
- 9.Lifton's huge ego that he, alone, found the real reason for Commission, staff, and critics for being "misled." Childish assumption that a piece of paper, a FBI report by James Sibert and Francis O'Neill made any difference. Rosetta Stone? No, Pet Rock
- 10. Lifton cant locate where, when, who, or how, second autopsy followed the first alteration. But why bother at all? JFK, immediately following surgical deception; to be embalmed, buried, chances nil of being exhumed. Why fix a corpse to plant it six feet?
- 11 Decision to make Oswald the patsy, no matter where he stood, made long in advance. Chicago, Miami plans proved this.

 Dallas Inquiry, later moved to DC, could handle the planted and forged evidence. Missing evidence never accounted for.

WHAT WAS THE BEST EVIDENCE IF THE WARREN COMMISSION WERE HONEST? Not JFK body.it wasnt available.

- A.Medical X-rays and photographs of JFK body before autopsy. Why did they use 3rd person drawings, and not real pictures?
- B. Jacket of JFK, Coat, shirt, compared to wounds, pictures, not drawings.
- C. Ask Henry Luce, Time, Newsweek, why rifle photos altered scope?
- D. Demand to know how Zapruder films cut, rearranged as evidence?
- E. Comparisons of bullet fragments, all of them, with verifiable reports.
- F. Why was Gov. John Connally clothing dry cleaned, not with FBI, Police?
- G. Who destroyed tape recordings, 48 hours, while Oswald alive?
- H. Why didnt Warren Commission allow Ruby protection, to talk?
- I. Who ordered JFK car interior destroyed, removed from DC.before any inquiry began?
- J. What proof, without prints, Oswald ordered rifle? Ask Kleins, FBI?
- K. Who destroyed Oswald mail box application, illegal to remove?
- L.Wny Oswald CIA papers "burned" Nov.23,1963.Passport file?
- M.Why werent Dealey Plaza pictures, tramps, etc, examined or wanted?
